The organization rescued 2,432,680 pounds of food for the fiscal year ending 06/30/2016. The food was used to feed children, adults and seniors through other social service agencies, and for job training in the food industry.

4b (Code:) (Expenses \$ **5,202,128** including grants of \$ **4,193,531**) (Revenue \$ **36,548**)

During the fiscal year ending 06/30/2016, 983,284 meals were prepared using rescued food. These meals are donated to over 85 501(c)(3) agencies serving children and adults.

Second Helpings also utilizes the rescued food to train adults for job placement in the culinary food industry. During the fiscal year ending 06/30/2016, five classes graduated with a total of 59 individual graduates. 48 people were placed in jobs through this program.
