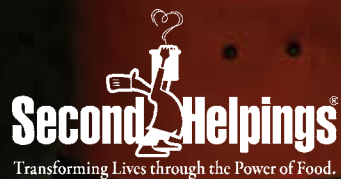

Each morning, the Hunger Relief kitchen fills with volunteers dedicated to making meals that will help children and families get the nutritious food they need to build better lives. Volunteers who deliver meals to shelters for men and women are greeted with smiles. Those smiles represent not only the promise of a good, hot meal but also the relief of knowing that they can continue to rebuild their lives without the worry of going hungry that day.

Graduates of the Culinary Job Training program transform not only their lives, but they also contribute to the ever-growing food service workforce in Central Indiana. Their commitment is why employment rates after graduation are as high as 100%.

Second Helpings rescued more than two million pounds of food last year and increased the number of hunger relief meals for its partner agencies by 11%. Each person represents one step in building a better community.
